- ***Reminder*** - The deadline to submit 2015-16 requisitions for purchase orders is April 22nd; everything should be submitted to your principal or supervisor for end-of-year purchases.

LiveHealth Online:

As a follow up to last month's update, building visits to assist employees with LiveHealth Online registration have been scheduled and will be the following dates/times:

- Monday, May 9th – High School from approximately 7:15 am through 12:45 pm;
- Monday, May 9th – Junior High from approximately 1:00 pm – 3:00 pm;
- Monday, May 9th – Central Elementary from approximately 3:15 pm – 4:00 pm;
- Tuesday, May 10th – Western Elementary from approximately 3:15 pm – 4:00 pm;
- Wednesday, May 11th – Eastern Elementary from approximately 3:15 pm – 4:00 pm.

The LiveHealth Online tool is an often overlooked benefit available through Anthem and is available 7 days a week, 24 hours per day. This tool provides a convenient and cost-effective way to gain access to doctors, receive a diagnosis, and obtain prescriptions for basic medications. Employees are able to talk to doctors through their mobile device or online by two-way video on a computer.

While the average cost for use of the tool is \$49, the normal office **co-pay for visits of \$10 would apply**. When applicable, use of the LiveHealth Online tool provides for significant convenience for employees. Additionally, the costs are significantly lower than standard doctor visits and can provide cost savings for our Employee Self Insurance Fund.

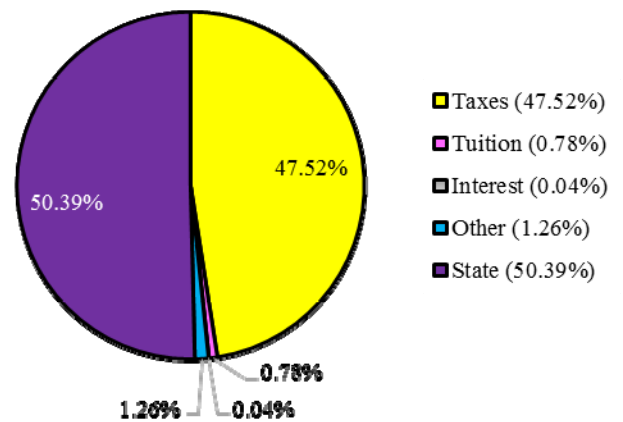
Financial Information:

As you know, last month District residents passed a 10 year renewal levy that generates approximately \$2.7 million annually. Also, as part of last month's update, I provided a breakdown of various District costs. This month I wanted to provide a breakdown of various District revenues that provide the resources necessary for the operations of the District to help shed some light on the importance of the continued strong support we receive from our community.

The table and graph below illustrate the cash receipts of the General Fund and provide perspective of the role community support plays in providing the necessary resources for the students of our District:
