## **Vision Insurance Update:**

By now, everyone who enrolled in the **Blue View Vision** plan offered by Anthem should have received their new Anthem ID cards in the mail.

As a reminder these new ID cards will be used for vision, medical, or dental and will replace previous ID cards. For any employees who did not enroll in the new vision plan, no new ID cards were issued and employees will continue to use their existing cards. The effective date of this vision coverage began on May 1, 2015.
