
From the office of the Treasurer...

- Also, in November, deductions for union dues will begin and run for 10 consecutive pays. Employees should note these deductions beginning with their November 3rd pay.

In total, approximately \$3,500 was raised from these efforts. As previously communicated through e-mail, these funds will be paid to Pasadena Independent School District to assist in replenishing instruments lost as a result of the hurricane.
