If a fundraiser activity has already been completed without completion of the Fundraiser Project Proposal Form, please complete and submit the form to the Treasurer's Office as soon as possible. Thank you for all you do to ensure the success of the various student activities throughout the District.

Financial Communications:

The District's financial audit is currently underway and nearing completion. The fiscal year 2015 financial statements have been compiled and provided to the auditors for review. Below is a breakdown of the General Fund, the District's largest fund:

Cash receipts and other financing sources of the General Fund totaled \$23,388,632 in 2015. The cash disbursements and other financing uses of the General Fund totaled \$20,649,915 in 2015. The General Fund's fund balance increased \$2,738,717 from 2014 to 2015.




